As per the guidelines issued by the Ministry of Corporate Affairs (MCA) vide Circular No. 20/2020 dated May 05, 2020 and Circular No 02/2022 dated May 05, 2022, Circular No. 10/2022 dated December 28, 2022, circular no.09/2023 dated September 25, 2023, Circular no. 09/2024 dated September 19, 2024 and by issuing the latest Circular no. 03/2025 dated September 22, 2025, MCA has allowed for conducting AGM or passing of Ordinary/ Special Resolution through “Video Conferencing” till further orders. The forthcoming AGM will thus be conducted through video conferencing (VC) or other audio-visual means (OAVM). Hence, members can attend and participate the ensuing AGM through VC/OAVM.
2. The Ministry of Corporate Affairs (MCA) vide General Circular No. 2/2022 dated May 5, 2022, Circular No. 10/2022 dated December 28, 2022, Circular No. 09/2023 dated September 25, 2023, Circular No. 09/2024 dated September 19, 2024 and SEBI vide Circular No. SEBI/HO/CFD/CMD2/CIR/P/2022/62 dated May 13, 2022, Circular No. SEBI/HO/CFD/CFD-PoD-2/P/CIR/2023/167 dated October 7, 2023 granted relaxation from dispatching physical copies of Annual Reports to the Shareholders by those listed entities who may conduct their Annual General Meetings (AGM) through electronic mode. Hence, no physical copy of Annual Report 2025-26 will be sent to the members/ shareholders.
3. Pursuant to the Circular No. 14/2020 dated April 08, 2020, issued by the Ministry of Corporate Affairs, the facility to appoint proxy to attend and cast vote for the members is not available for this AGM. However, the Body Corporates are entitled to appoint authorised representatives to attend the AGM through VC/OAVM and participate there at and cast their votes through e-voting.
4. The Members can join the AGM in the VC/OAVM mode 15 minutes before and after the scheduled time of the commencement of the Meeting by following the procedure mentioned in the Notice. The facility of participation at the AGM through VC/OAVM will be made available for 1000 members on first come first served basis. This will not include large Shareholders (Shareholders holding 2% or more shareholding), Promoters, Institutional Investors, Directors, Key Managerial Personnel, the Chairpersons of the Audit Committee, Nomination and Remuneration Committee and Stakeholders Relationship Committee, Auditors etc. who are allowed to attend the AGM without restriction on account of first come first served basis.
5. The attendance of the Members attending the AGM through VC/OAVM will be counted for the purpose of reckoning the quorum under Section 103 of the Companies Act, 2013.
6. Pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015 (as amended), and MCA Circulars May 05, 2020, May 05, 2022, December, 28, 2022, September 25, 2023, September 19, 2024 and September 22, 2025 the Company is providing facility of remote e-voting to its Members in respect of the business to be transacted at the ensuing AGM. For this purpose, the Company has entered into an agreement with National Securities Depository Limited (NSDL) for facilitating voting through electronic means, as the

authorized e-Voting's agency. The facility for casting votes by a member through remote e-voting and as well as the facility for e-voting system on the date of the EGM will also be provided by NSDL.

7. In line with the Ministry of Corporate Affairs (MCA) Circular No. 17/2020 dated April 13, 2020, the Notice calling the AGM has been uploaded on the website of the Company at www.assamcarbon.in. The Notice can also be accessed from the websites of The Calcutta Stock Exchange Ltd at www.cse-india.com and the AGM Notice is also available on the website of NSDL (agency for providing the Remote e-Voting facility) i.e. www.evoting.nsdl.com.
8. AGM has been convened through VC/OAVM in compliance with applicable provisions of the Companies Act, 2013 read with MCA Circular No. 14/2020 dated April 08, 2020 and MCA Circular No. 17/2020 dated April 13, 2020, MCA Circular No. 20/2020 dated May 05, 2020, MCA Circular No. 2/2021 dated January 13, 2021, MCA Circular No. 10/2022 dated December, 28, 2022, MCA Circular No. 09/2023 dated September 25, 2023, Circular No. 09/2024 dated September 19, 2024 and 03/2025 dated September 22, 2025.
9. Dividend
 1. The Board of Directors has recommended for consideration of the Shareholders a dividend of 40% i.e. Rs4- per Equity share of the nominal value of ₹ 10/- each for the year ended 31st March, 2026.
 2. The Register of Members and Share **Transfer books of the Company will remain closed from Tuesday, 1st September, 2026, to Monday, 7th September, 2026** (both days inclusive), for the purpose of AGM and Dividend. The Dividend, if declared and approved, will be payable on or after **Monday, 7th September, 2026**, to those Shareholders whose names are registered as such in the Register of Members of the Company as on **Monday, 31st August, 2026** and to the beneficiary holders as per the beneficiary list as on **Monday, 31st August, 2026** provided by the NSDL and CDSL, subject to deduction of tax as applicable.

Payment of Dividend through electronic means:

- (a) The Company provides the facility to the Shareholders for remittance of dividend directly in electronic mode / through National Automated Clearing House (NACH). In view of the difficulties involved in dispatching of physical dividend warrants, Shareholders holding shares in physical form and desirous of availing this facility of electronic remittance are requested to provide their latest bank account details (Core Banking Solutions Enabled Account Number, 9digit MICR and 11digit IFSC Code), along with their Folio Number, to the Company. Shareholders holding shares in dematerialized form are requested to provide the said details to their respective Depository Participants.
- (b) Shareholders holding shares in dematerialized form are hereby informed that bank particulars registered against their respective depository accounts will be used by the Company/ RTA for payment of dividend. The Company/ RTA can't act on any request received directly from the Shareholders holding shares in dematerialized form for any change of bank particulars or bank mandates. Such changes are to be advised only to the Depository Participant of the Shareholders.
- (c) Pursuant to Finance Act 2020, dividend income will be taxable in the hands of Shareholders with effect from 1st April, 2020 and the Company is required to deduct tax at source from dividend paid to the Shareholders at the prescribed rates. For the prescribed rates for various categories, the Shareholders are requested to refer to the Finance Act, 2020 and amendments thereof. The Shareholders are requested to update their PAN with the Company/ RTA (in case of shares held in physical mode) and their respective Depository Participants (in case of shares held in dematerialised form). A Resident individual shareholder with PAN and who is not liable to pay income tax can submit a yearly declaration in Form No. 121, to avail the benefit of non-deduction of tax at source by email to acpl.compliance@gmail.com by 30th August, 2026. As per the Income Tax Act, 1961, the dividend income is taxable in the hands of shareholders. Accordingly, if any resident individual shareholder is in receipt of dividend exceeding Rs.10,000/- in a fiscal year, entire dividend will be subject to TDS @ 10%. The rate of 10% is applicable provided the shareholder has updated his/ her Permanent Account Number (PAN) with the depository/ Registrar and Transfer Agent (RTA). Shareholders are requested to note that in case their PAN is not registered, the tax will be deducted at a higher rate of 20%. Resident shareholders who are eligible for deduction of TDS at a concessional or Nil rate as per Section 197 of the Income-tax Act, 1961, can submit the certificate/letter issued by the Assessing Officer, to avail the benefit of lower rate of deduction or non-deduction of tax at source by Email to acpl.compliance@gmail.com by 30th August, 2026. Non-resident Shareholders can avail beneficial rates under tax treaty between India and their country of residence, subject to providing necessary documents i.e. No Permanent Establishment

and Beneficial Ownership Declaration, Tax Residency Certificate, Form 10F, any other document which may be required to avail the tax treaty benefits by sending an Email to acpl.compliance@gmail.com. The aforesaid declarations and documents need to be submitted by the Shareholders by 30th August, 2026.

- (d) In terms of the provisions of Sections 124 and 125 of the Act, dividend which remains unpaid/ unclaimed for a period of 7 (seven) years from the date of declaration is required to be transferred to the Investor Education and Protection Fund ("IEPF") established by the Central Government. Further, in terms of the provisions of Section 124 of the Act read with the Investor Education and Protection Fund Authority (Accounting, Audit, Transfer and Refund) Rules, 2016 ("IEPF Rules"), Equity Shares in respect of which dividend has not been paid or claimed for 7 (seven) consecutive years or more from the date of declaration, are also required to be transferred to an account viz. IEPF Suspense Account, which is operated by the IEPF Authority pursuant to the IEPF Rules. All equity shares of the Company on which dividend has not been paid or claimed for 7 (seven) consecutive years or more, shall be transferred by the Company to the IEPF from time to time. Details of unpaid / unclaimed dividend and equity shares transferred to IEPF are uploaded on the website of the Company as well as that of the Ministry of Corporate Affairs, Government of India ("MCA"), if any. No claim shall lie against the Company in respect of unclaimed dividend amount and equity shares transferred to the IEPF and IEPF Suspense Account, respectively, pursuant to the IEPF Rules. Shareholders can however claim both the unclaimed dividend amount and the equity shares from the IEPF Authority by making an online application in web Form No. IEPF-5, the details of which are available at www.iepf.gov.in.

 - (a) As an on-going measure to enhance the ease of doing business for investors in the securities market, SEBI vide Circular Nos. SEBI/HO/MIRSD/MIRSD_RTAMB/P/ CIR/2021/655 dated November 03, 2021, SEBI/HO/MIRSD/MIRSD_RTAMB/P/ CIR/2021/687 dated December 14, 2021, SEBI/HO/MIRSD/MIRSD-PoD-1/P/CIR/2023/37 dated March 16, 2023 and SEBI/HO/MIRSD/POD-1/P/CIR/2023/181 dated November 17, 2023. It will be mandatory for all holders of physical securities in listed companies to furnish PAN, Nomination, contact details, Bank A/c details and Specimen signature for their corresponding folio numbers for Payment including dividend, interest or redemption payment, only through electronic mode with effect from April 01, 2024.

The remote e-voting period begins on **Friday, 4th September, 2026 at 9:00 A.M.** and ends on **Sunday, 6th September, 2026 at 5:00 P.M.** The remote e-voting module shall be disabled by NSDL for voting thereafter. The Members, whose names appear in the Register of Members / Beneficial Owners as on the record date (cut-off date) i.e. **31st August, 2026** may cast their vote electronically. The voting right of shareholders shall be in proportion to their share in the paid-up equity share capital of the Company as on the cut-off date, being **31st August, 2026**.

How do I vote electronically using NSDL e-Voting system?

The way to vote electronically on NSDL e-Voting system consists of "Two Steps" which are mentioned below:

Step 1: Access to NSDL e-Voting system

A) Login method for e-Voting and joining virtual meeting for Individual shareholders holding securities in demat mode

In terms of SEBI circular dated December 9, 2020 on e-Voting facility provided by Listed Companies, Individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. Directors' Report

To the Members,

Your Directors are pleased to present the 63rd Annual Report on the business and operations of the Company along with the Audited Financial Accounts for the financial year ended 31st March, 2026.

1. CORPORATE OVERVIEW

Assam Carbon Products Limited is a market leader in Electrical, Mechanical, and Specialty Carbon Products, with two strategically located manufacturing units at Guwahati (Assam) and Patancheru (near Hyderabad, Telangana).

Manufacturing Units & Capabilities

Guwahati Facility :

The Guwahati plant serves as the Company's primary unit for manufacturing high-grade carbon and graphitised blocks and blanks. These semi-finished products form the core raw material for electrical carbon applications, primarily carbon brushes used across critical sectors such as Indian Railways, steel plants, paper and sugar mills, power utilities, mining, and industrial motors/generators.

The facility also produces specialized, high-purity carbon solutions for mechanical carbon applications. Blocks and blanks manufactured at Guwahati are either processed in-house for brush fabrication or transferred to the Patancheru unit for precision machining, customization, and commercial dispatch.

Patancheru Facility :

The Patancheru unit is a state-of-the-art precision machining and fabrication facility, serving as the Company's primary hub for finished mechanical components and advanced electrical brush assemblies.

Electrical Carbon Division: Manufactures precision-engineered carbon brushes, railway traction components (including pantograph strips and current collectors), silver-impregnated graphite products, and railway signaling contacts.

Mechanical Carbon Division: Specializes in custom-engineered seals, radial/thrust bearings, vanes, and gland rings, manufactured to exact tolerances using advanced CNC machining facilities.

Specialty & Engineered Graphite: Produces high-temperature insulators, fuel cell components, heating elements, casting dies, continuous casting die sets, and customized graphite components for specialized industrial processes.

Strategic Priorities :

Across both manufacturing locations, the Company remains dedicated to:

- Driving product innovation and delivering tailor-made engineering solutions.
- Maintaining stringent quality assurance standards and tight manufacturing tolerances.
- Upgrading process technology and expanding CNC machining capabilities.
- Delivering excellence in after-sales technical support.
- Deepening strategic partnerships across key sectors, including Railways, Power, Steel, Automotive, and Electronics.

3. OPERATIONS AND STATE OF COMPANY'S AFFAIRS

During the year under review, revenue from operations of the Company increased to ₹ 7988.95 Lakhs as compared to ₹ 6834.77 Lakhs in the previous year. With the increased Turnover, the Company was able to close the year with a profit of ₹ 1858.62 Lakhs (before provision of tax) as against a previous year's profit of ₹ 1252.39 Lakhs.

During the year, your Company incurred a forex gain of ₹ 13.43 Lakhs as compared to a forex gain of ₹ 1.49 Lakhs in the previous year.

During the year, your Company achieved an export sales of ₹ 170.43 Lakhs as against ₹ 123.46 Lakhs in the previous year. However, the management has taken strong initiative and is confident that exports will pick-up in the coming years.

During the year, your Company has further worked actively towards rationalizing its business and product portfolio, whilst adding new product lines, to better utilise the available talent and resources and stay abreast of the market dynamics in new products.

Your Company is also moving ahead aggressively in increasing its capacity, both at its Guwahati as well as Hyderabad factories and is also looking at adding a few new products which have been identified. The Capex has been identified for:

- A. Capacity Enhancement, and
- B. New Products

During the year under review, your Company successfully obtained registration for its capacity expansion project under the Government of Assam's UNNATI Scheme. As part of this initiative, the Company incurred capital expenditure of approximately ₹1,531 Lakhs at its Guwahati plant up to the end of the financial year under review.

The capital expenditure is expected to enhance operational efficiency, strengthen manufacturing capabilities, support the Company's long-term growth strategy, and ensure continued compliance with applicable regulatory and industry standards. The project has been financed through a combination of term loans and internal accruals, and the major activities remain on schedule and within the approved budget.

In addition, the Company incurred capital expenditure of approximately ₹406 Lakhs at its Patancheru (Hyderabad) plant towards capacity augmentation, modernization, and enhancement of manufacturing facilities.

Upon completion, the ongoing capital expenditure programme across both manufacturing facilities is expected to more than double the Company's production capacity. This significant expansion will strengthen the Company's ability to cater to the rapidly growing demand for its products, improve operational efficiencies, and position it for sustained long-term growth.

FUTURE OUTLOOK

Macroeconomic Context :

India remains one of the world's fastest-growing major economies, supported by sustained public capital expenditure in infrastructure, railways, defense, power transmission, and urban mobility. Government initiatives such as Make in India and Atmanirbhar Bharat, alongside expanding private sector capital expenditure, continue to unlock robust growth opportunities for the domestic engineering and manufacturing sectors.

Against this backdrop, Assam Carbon Products Ltd. (ACPL) is well-positioned to capitalize on increasing demand for Electrical Carbon, Mechanical Carbon, and Specialty Graphite products. The commissioning of ongoing capacity expansion projects at both Guwahati and Patancheru will significantly enhance manufacturing capabilities, improve cost efficiencies, and enable the Company to address larger, higher-value market opportunities.

Segment-Wise Growth Drivers :

a) Electrical Carbon Business

Demand for Carbon Brushes, Current Collectors, Metallised Carbon Strips, Pantograph Assemblies, and Railway Signalling Contacts is expected to remain buoyant, driven by:

- Accelerated electrification, track expansion, and fleet modernization by Indian Railways.
- Rapid expansion of Metro Rail networks across tier-1 and tier-2 cities.
- Industrial automation and increased electrification across core sectors.
- Capacity additions and modernization in steel, cement, mining, paper, sugar, and power utilities.
- Higher overhaul, refurbishment, and maintenance cycles for rotating electrical equipment.

b) Mechanical Carbon Business

The Mechanical Carbon business is poised for healthy growth, supported by capital investments in process industries such as petrochemicals, specialty chemicals, pharmaceuticals, power generation, and water management.

Growing industry focus on equipment reliability, energy efficiency, and localized sourcing will drive demand for

high-precision components, including mechanical seals, bearings, thrust pads, and vanes. The Company's enhanced precision machining capabilities provide a strong competitive edge in meeting these strict tolerance requirements.

c) Specialty Graphite Products

ACPL continues to expand its footprint in high-value Specialty Graphite applications. Key target industries include electronics, hard metal sintering, diamond tooling, optical fiber manufacturing, and high-temperature thermal processing. Custom-engineered graphite components present attractive opportunities for product diversification and margin enhancement.

d) Export Footprint

Global original equipment manufacturers (OEMs) are actively diversifying their supply chains, creating strong prospects for Indian engineering companies with proven quality credentials. The Company intends to expand its international presence across the Middle East, Africa, Southeast Asia, and other strategic markets by offering cost-competitive, technologically advanced products across all three business verticals.

e) Technology & Operational Excellence :

The Company continues to invest in process automation, product development, and operational excellence. Modernization initiatives underway are designed to boost productivity, optimize manufacturing costs, and reduce lead times while upholding stringent safety and quality standards.

Overall Outlook:

While geopolitical tensions, currency fluctuations, and raw material price volatility may pose short-term headwinds, the long-term fundamentals of the Indian manufacturing ecosystem remain highly favorable. With expanded capacities, an agile product portfolio, deep technical expertise, and a disciplined approach to capital allocation, your Company remains confident of delivering sustainable long-term growth and stakeholder value.

4. DIVIDEND

Over the past few years, the Company has been navigating a challenging and transitional phase, amplified further by the impact of the COVID-19 pandemic and structural shifts in customer demand. Even before the pandemic, the Company's key customer - Indian Railways embarked on a strategic transformation by migrating from diesel to AC locomotives. This technological shift significantly reduced the requirement for our traditional products, leading to a drastic drop in offtake.

In light of these developments, the Company recognizes the urgent need to redefine its product portfolio and reduce dependency on legacy demand. This strategic shift will require significant capital expenditure (Capex) aimed at:

- Diversifying product offerings,
- Entering adjacent markets,
- Leveraging existing capabilities for new industrial segments.

The management remains committed to this transition and is taking active steps to reposition the Company for sustainable growth through technology upgradation, capacity enhancement, and market diversification.

In spite of the above facts, the Company as a commitment to its Shareholders, at their meeting held on 22nd May 2026 recommended for payment of a dividend @ ₹ 4/- per equity share of ₹ 10/- each amounting to total of ₹ 110.22 Lakhs and subject to approval by the shareholders at the forthcoming Annual General Meeting of the Company.

Management Discussion and Analysis Report

INDUSTRY STRUCTURE & DEVELOPMENT

During FY 2025–26, ACPL reinforced its market position as a premier manufacturer of Electrical Carbon, Mechanical Carbon, and Specialty Graphite products in India. Backed by over six decades of manufacturing heritage, the Company delivers mission-critical carbon solutions essential to continuous industrial operations domestically and globally.

The Company's integrated manufacturing chain enables the synthesis of carbon, graphite, and metal-matrix materials, which are engineered into value-added products, including:

- Precision Carbon Brushes for industrial and traction motors.
- Current Collectors and Metallised Carbon Strips for High-Speed Railways and Metro systems.
- Carbon & Graphite Mechanical Seals, Radial/Thrust Bearings, and Vanes.
- Gland Rings, Steam Joints, and Specialty Graphite Components.
- Customized engineered solutions for extreme thermal, chemical, and wear environments.

Domestic & Global Operating Environment :

Domestic Landscape: Strong macro trends, such as the expansion of dedicated freight corridors, renewable energy integration, and industrial corridors - have bolstered structural demand for specialized components. Concurrently, supply chain localization trends are encouraging domestic original equipment manufacturers (OEMs) to replace imports with reliable indigenous alternatives.

Global Landscape: Global markets experienced continuing geopolitical re-alignments, trade policy shifts, and interest rate realignments during the year. Despite these uncertainties, global procurement teams are seeking resilient secondary supply bases, opening new avenues for qualified Indian exporters like ACPL.

Business Segment Performance Trends :

Electrical Carbon Segment :

The transition of Indian Railways from conventional DC traction to modern AC traction technologies has progressively altered demand patterns for traditional brush categories. In response, ACPL has strategically pivoted toward high-value AC traction products, pantograph strip assemblies, current collectors, and diversified industrial applications to safeguard and grow segment revenues.

Mechanical Carbon & Specialty Graphite Segment :

The Mechanical Carbon segment demonstrated solid momentum, driven by demand from chemical, petrochemical, and power generation industries. Carbon's unique properties - self-lubrication, high chemical inertness, thermal stability, and low thermal expansion - make it indispensable in demanding mechanical environments. This segment remains a major engine for the Company's future margin expansion.

OPPORTUNITIES & THREATS

Opportunities:

- **Infrastructure & Industrial Expansion:** Federal capital expenditure in railways, defense, power transmission, and heavy industries provides a multi-year growth runway for ACPL's product portfolio.
- **Urban Transit & Freight Modernization:** The rapid expansion of Metro Transit Networks, Regional Rapid Transit Systems (RRTS), and Dedicated Freight Corridors creates sustained demand for Pantograph Strips, Silver-Graphite Contacts, and Collector Shoes.
- **Process Industry Automation:** Rising operational standards in chemicals, pharmaceuticals, and power generation spur demand for high-reliability Mechanical Seals, Bearings, and Vanes.
- **Import Substitution:** National push toward supply chain indigenization enables ACPL to offer domestically manufactured, cost-effective alternatives to imported carbon components.
- **Specialty Graphite Adoption:** Emerging technical applications in semiconductors, optical fibers, and renewable energy technologies present high-margin diversification avenues.

Management Discussion and Analysis Report (Contd.)

Threats & Mitigation Strategies :

- **Raw Material Price Volatility:** Key inputs such as synthetic graphite, pitch, metallic powders, and specialized resins remain subject to global commodity cycles.

Mitigation: The Company mitigates input cost volatility through long-term sourcing contracts, strategic inventory management, and structured price-pass-through arrangements where feasible.

- **Technology Transitions:** The rise of brushless motors and alternative wear materials could diminish long-term demand for traditional carbon brushes in specific applications.

Mitigation: ACPL actively invests in R&D to develop advanced material grades and expand into mechanical and specialty graphite applications.

- **Low-Cost Import Competition:** Influx of low-priced carbon products from overseas markets exerts pricing pressure on standard product lines.

Mitigation: Focus on high-precision machining, custom engineering, strict quality compliance, and responsive after-sales support creates high entry barriers against low-cost commoditized imports.

- **Macroeconomic & Geopolitical Risks:** Geopolitical friction and currency fluctuations can impact export volumes and landed raw material costs.

Mitigation: Broadening geography footprint and maintaining a resilient balance sheet help absorb short-term global shocks.

SEGMENT-WISE/PRODUCT-WISE PERFORMANCE

Company has achieved a gross revenue from operation amounting to ₹ 7989 Lakhs as against ₹ 6835 Lakhs in the last financial year, an increase of 16.88% as compared to the previous financial year.

Sale of Electrical segment has contributed 66% to the top line as against 64% in the previous fiscal, whilst the Mechanical & Speciality Carbon segment witnessed a share of 34% as against 36% in the previous year. The Mechanical segment is still down due to low demand but in the years ahead the Company will be more and more concentrating upon the mechanical and specialty segments.

Performance of the Company continues to improve due to various cost saving measures and operational efficiency measures initiated by the management, as well as rationalization of sales price, strict control on credit sales and staying away from loss making accounts.

OUTLOOK

Macroeconomic Context :

India remains one of the world's fastest-growing major economies, supported by sustained public capital expenditure in infrastructure, railways, defense, power transmission, and urban mobility. Government initiatives such as Make in India and Atmanirbhar Bharat, alongside expanding private sector capital expenditure, continue to unlock robust growth opportunities for the domestic engineering and manufacturing sectors.

Against this backdrop, Assam Carbon Products Ltd. (ACPL) is well-positioned to capitalize on increasing demand for Electrical Carbon, Mechanical Carbon, and Specialty Graphite products. The commissioning of ongoing capacity expansion projects at both Guwahati and Patancheru will significantly enhance manufacturing capabilities, improve cost efficiencies, and enable the Company to address larger, higher-value market opportunities.

Segment-Wise Growth Drivers :

f) Electrical Carbon Business

Demand for Carbon Brushes, Current Collectors, Metallised Carbon Strips, Pantograph Assemblies, and Railway Signalling Contacts is expected to remain buoyant, driven by:

- Accelerated electrification, track expansion, and fleet modernization by Indian Railways.
- Rapid expansion of Metro Rail networks across tier-1 and tier-2 cities.
- Industrial automation and increased electrification across core sectors.
- Capacity additions and modernization in steel, cement, mining, paper, sugar, and power utilities.
- Higher overhaul, refurbishment, and maintenance cycles for rotating electrical equipment.

Management Discussion and Analysis Report (Contd.)

g) Mechanical Carbon Business

The Mechanical Carbon business is poised for healthy growth, supported by capital investments in process industries such as petrochemicals, specialty chemicals, pharmaceuticals, power generation, and water management.

Growing industry focus on equipment reliability, energy efficiency, and localized sourcing will drive demand for high-precision components, including mechanical seals, bearings, thrust pads, and vanes. The Company's enhanced precision machining capabilities provide a strong competitive edge in meeting these strict tolerance requirements.

h) Specialty Graphite Products

ACPL continues to expand its footprint in high-value Specialty Graphite applications. Key target industries include electronics, hard metal sintering, diamond tooling, optical fiber manufacturing, and high-temperature thermal processing. Custom-engineered graphite components present attractive opportunities for product diversification and margin enhancement.

i) Export Footprint

Global original equipment manufacturers (OEMs) are actively diversifying their supply chains, creating strong prospects for Indian engineering companies with proven quality credentials. The Company intends to expand its international presence across the Middle East, Africa, Southeast Asia, and other strategic markets by offering cost-competitive, technologically advanced products across all three business verticals.

j) Technology & Operational Excellence :

The Company continues to invest in process automation, product development, and operational excellence. Modernization initiatives underway are designed to boost productivity, optimize manufacturing costs, and reduce lead times while upholding stringent safety and quality standards.

Overall Outlook:

While geopolitical tensions, currency fluctuations, and raw material price volatility may pose short-term headwinds, the long-term fundamentals of the Indian manufacturing ecosystem remain highly favorable. With expanded capacities, an agile product portfolio, deep technical expertise, and a disciplined approach to capital allocation, your Company remains confident of delivering sustainable long-term growth and stakeholder value.

RISKS & CONCERNS

Unforeseen/unmitigated technology obsolescence, the emergence of competing technologies would impact the Company's business and its ability to deliver on its strategic goals.

The advanced technological nature of the Company requires people with highly differentiated skill sets. Any inability to recruit, retain and develop the right people would impact the Company's ability to achieve its strategic goals.

Supplying into critical applications, the quality of the Company's contracts must match the quality and nature of its products. Ineffective contract risk management could result in significant liabilities for the Company and damage customer relationships.

Further, massive and unpredicted increase in the Raw Material price and volatility in the consumables prices has reduced the profit margin of the Company.

INTERNAL CONTROL SYSTEM & THEIR ADEQUACY

The Company has proper and adequate internal control system commensurate with its size and nature of business. It ensures that all assets are safeguarded and protected against improper use and that transactions are authorized, recorded and reported correctly.

Internal Audit is conducted by independent auditing firm at all locations of the Company. The internal audit reports are reviewed by the Audit Committee and adequate remedial measures are taken in time.

FINANCIAL PERFORMANCE WITH RESPECT TO OPERATIONAL PERFORMANCE

During the year under review, revenue from operations of the Company closed at ₹ 7989 Lakhs as compared to ₹ 6835 Lakhs in the previous year which is a 16.88% increase.

During FY 2025–26, the Company navigated a complex operating environment marked by input cost volatility, aggressive pricing from low-cost imports (particularly from Asian markets), and macroeconomic shifts. Fluctuations in foreign exchange rates during parts of the financial year increased the landed cost of imported raw materials and specialized inputs, placing pressure on operating margins.

In response, the management executed targeted operational interventions:

- **Product Portfolio Optimization:** Shifted focus toward higher-margin, custom-engineered mechanical components and specialty graphite products.
- **Cost Rationalization & Procurement Strategy:** Implemented prudent raw material procurement, optimized energy consumption, and tightened shop-floor yields.
- **Process Automation:** Enhanced machining throughput and turnaround times at the Patancheru unit to better serve customer schedules.

Through these measures, the Company successfully mitigated margin compression, maintained operational continuity, and delivered a resilient operational and financial performance for the year under review.

The management remains committed to enhancing cost competitiveness, deepening customer relationships, and executing planned capacity expansions to drive profitable growth in the upcoming financial year.

HUMAN RESOURCES/INDUSTRIAL RELATIONS

The Company has always given prime importance to Human Resources. Continued efforts towards optimum manpower utilization are being made for reduction of cost and optimization of productivity. The Company continues to provide thrust on regular training programmes for upgradation of job knowledge and other related skills amongst its employees.

Notes to the Financial Statements for the year ended 31st March, 2026

1.A. ABOUT THE COMPANY

Assam Carbon Products Limited is a public company. It is incorporated under the Companies Act, 1956 and its shares are listed on the Calcutta Stock Exchange Limited. The Company is primarily engaged in manufacture of carbon products.

1.B. SIGNIFICANT ACCOUNTING POLICIES

i. Basis of preparation of financial statements

These financial statements have been prepared in accordance with Indian Accounting Standards (referred to as 'Ind AS') as per the Companies (Indian Accounting Standards) Rules, 2015, notified under Section 133 of the Companies Act, 2013 ('the Act') and other accounting principles generally accepted in India, to the extent applicable.

The financial statements are presented in Indian Rupees, which is the Company's functional and presentation currency and all the amounts are rounded off to nearest thousand (Rs. 000) except as stated otherwise.

ii. Use of estimates

The preparation of the financial statements in conformity with IND AS requires management to make estimates, judgments and assumptions. These estimates, judgements and assumptions affect the application of accounting policies and the reported amounts of assets and liabilities, the disclosures of contingent assets and liabilities at the date of the financial statements and reported amounts of revenues and expenses during the period. Accounting estimates could change from period to period. Actual results could differ from those estimates. Appropriate changes in estimates are made as management becomes aware of changes in circumstances surrounding the estimates. Differences between the actual results and estimates are recognised in the year in which the results are known / materialized and, if material, their effects are disclosed in the notes to the financial statements.

Key sources of estimation uncertainty

The following are the key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period that may have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

1. Useful lives of property, plant and equipment

As described in the significant accounting policies, the Company reviews the estimated useful lives of property, plant and equipment at the end of each reporting period.

2. Fair value measurements and valuation processes

Some of the Company's assets and liabilities are measured at fair value for financial reporting purposes. In estimating the fair value of an asset or a liability, the Company uses market-observable data to the extent it is available. Where Level 1 inputs are not available, the Company engages third party valuers, where required, to perform the valuation. Information about the valuation techniques and inputs used in determining the fair value of various assets, liabilities are disclosed in the notes to the financial statements.

3. Claims, Provisions and Contingent Liabilities

In case of any ongoing dispute / litigation, where an outflow of funds is believed to be probable and a reliable estimate of the outcome of the dispute can be made based on management's assessment of specific circumstances of each dispute and relevant external advice, management provides for its best estimate of the liability. Such accruals are by nature complex and can take number of years to resolve and can involve estimation uncertainty.

4. Actuarial Valuation

The determination of Company's liability towards defined benefit obligation to employees is made through independent actuarial valuation including determination of amounts to be recognised in the Statement of Profit and Loss and in other comprehensive income. Such valuation depend upon assumptions determined after taking into account inflation, seniority, promotion and other relevant factors such as supply and demand factors in the employment market. Information about such valuation is provided in notes to the financial statements.

iii. Current – non current classification

All assets and liabilities have been classified as current or non-current as per the Company's normal operating cycle and other criteria set out in the Schedule III to the Companies Act, 2013. Based on the nature of operations, the Company has ascertained its operating cycle for the purpose of current – non current classification of assets and liabilities as 12 months.

All assets and liabilities are classified into current and non-current.

Assets

An asset is classified as current when it satisfies any of the following criteria:

- it is expected to be realised in, or is intended for sale or consumption in, the company's normal operating cycle;
- it is held primarily for the purpose of being traded;
- it is expected to be realised within 12 months after the reporting date; or
- it is cash or cash equivalent unless it is restricted from being exchanged or used to settle a liability for at least 12 months after the reporting date.

Current assets include the current portion of non-current financial assets.

All other assets are classified as non-current.

Liabilities

A liability is classified as current when it satisfies any of the following criteria:

- it is expected to be settled in the company's normal operating cycle;
- it is held primarily for the purpose of being traded;
- it is due to be settled within 12 months after the reporting date; or
- the company does not have an unconditional right to defer settlement of the liability for at least 12 months after the reporting date. Terms of a liability that could, at the option of the counterparty, result in its settlement by the issue of equity instruments do not affect its classification.

Current liabilities include current portion of non-current financial liabilities.

All other liabilities are classified as non-current.

iv. Fair Value Measurement

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date under current market conditions.

The Company categorizes assets and liabilities measured at fair value into one of three levels depending on the ability to observe inputs employed in their measurement which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities
- Level 2 inputs are inputs that are observable, either directly or indirectly, other than quoted prices included within level 1 for the asset or liability.
- Level 3 inputs are unobservable inputs for the asset or liability.

v. Property Plant and Equipment

Freehold land is carried at historical cost. All other items of Properties plant and equipment are stated at their cost of acquisition (net of input credit) or construction and are net of accumulated depreciation. The cost comprises purchase price, borrowing cost if capitalization criteria are met and directly attributable cost of bringing the asset to its working condition for the intended use. When significant parts of plant and equipment are required to be replaced at intervals, the Company depreciates them separately based on their specific useful lives. All other repair and maintenance costs are recognised in statement of profit or loss as incurred.

An item of property, plant and equipment and any significant part initially recognised is derecognized upon

disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss arising on de-recognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in the statement of profit and loss when the asset is derecognized.

Spares that can be used only with particular items of plant and machinery and such usage is expected to be irregular are capitalised.

Fixed assets under construction are disclosed as capital work in progress.

Depreciation

Depreciation on property plant and equipment commences when the assets are ready for their intended use.

Depreciation on tangible fixed assets is provided under straight line method over useful lives of fixed assets, as estimated by the management. Useful lives so estimated are in line with the useful lives indicated by Schedule II to the Companies Act, 2013. Depreciation on additions/ deletions is provided on pro rata basis in the year of purchase/ disposal.

The residual values, useful lives and method of depreciation of are reviewed at each financial year end and adjusted prospectively, if appropriate.

vi. Intangible fixed assets

Intangible assets are stated at their cost of acquisition net of amortisation. The cost comprises purchase price, borrowing cost if capitalization criteria are met and directly attributable cost of bringing the asset to its working condition for the intended use.

Application software is amortised over the estimated economic useful life of 6 years.

The amortization period and the amortization method are reviewed at least at each financial year end. If the expected useful life of the asset is significantly different from previous estimates, the amortization period is changed accordingly.

vii. Impairment of non-financial Assets

The Company assesses at each balance sheet date whether there is any indication that an asset may be impaired. If any such indication exists, the Company estimates the recoverable amount of the asset. If such recoverable amount of the asset or the recoverable amount of the cash generating unit to which the asset belongs is less than its carrying amount, the carrying amount is reduced to its recoverable amount. The reduction is treated as an impairment loss and is recognized in the statement of profit and loss.

An impairment loss is reversed if there has been a change in the estimates used to determine the recoverable amount. An impairment loss is reversed only to the extent that the assets carrying amount does not exceed the carrying amount that would have been determined net of depreciation or amortisation, if no impairment loss had been recognised.

viii. Financial Instruments

a. Financial Assets

Financial assets, where applicable are recognised when the Company becomes a party to the contractual provisions of the financial instrument and are measured initially at fair value adjusted for transaction costs.

Classification

Management determines the classification of an asset at initial recognition depending on the purpose for which the assets were acquired. The subsequent measurement of financial assets depends on such classification.

The financial assets are classified as those measured at:

1. amortised cost, where the financial assets are held solely for collection of cash flows arising from payments of principal and / or interest.
2. fair value through other comprehensive income (FVTOCI), where the financial assets are held not only for collection of cash flows arising from payments of principal and interest but also from the sale of such assets. Such assets are subsequently measured at fair value, with unrealised gains and losses arising from changes in the fair value being recognised in other comprehensive income.

3. fair value through profit or loss (FVTPL), where the assets are managed in accordance with an approved investment strategy that triggers purchase and sale decisions based on their fair value of such assets. Such assets are subsequently measured at fair value, with unrealised gains and losses arising from changes in the fair value being recognised in the Statement of Profit and Loss in the period in which they arise.

Trade receivables, advances, security deposits, cash and cash equivalents etc. are classified for measurement at amortised cost while investments may fall under any of the aforesaid classes. However, in respect of particular investments in equity instruments that would otherwise be measured at fair value through profit or loss, an irrevocable election at initial recognition may be made to present subsequent changes in fair value through other comprehensive income.

Impairment

The Company assesses at each reporting date whether a financial asset (or a group of financial assets) such as investments, trade receivables, advances and security deposits held at amortised cost and financial assets that are measured at fair value through other comprehensive income are tested for impairment based on evidence or information that is available without undue cost or effort. Expected credit losses are assessed and loss allowances recognised if the credit quality of the financial asset has deteriorated significantly since initial recognition.

De-recognition

A financial asset is primarily de-recognised when the rights to receive cash flows from the asset have expired or the Company has transferred its rights to receive cash flows from the asset.

- b. Financial Liabilities

All financial liabilities are recognised initially at fair value and transaction cost that is attributable to the acquisition of the financial liabilities is also adjusted. These liabilities are classified as amortised cost.

Subsequent to initial recognition, these liabilities are measured at amortised cost using the effective interest method. These liabilities include borrowings and deposits.

De-recognition of financial liabilities

A financial liability are de-recognised when the obligation under the liability is discharged, cancelled or expires. When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as the de-recognition of the original liability and the recognition of a new liability. The difference in the respective carrying amounts is recognised in the Statement of Profit and Loss.

- c. Offsetting Financial Instruments

Financial assets and financial liabilities are offset and the net amount is reported in the balance sheet if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, to realize the assets and settle the liabilities simultaneously.

ix. Inventories

Raw materials, stores and spare parts are valued at the lower of cost and net realizable value. Cost includes purchase price, duties and taxes, freight and other expenditure incurred in bringing such inventories to their present location and condition. In determining cost, weighted average method is used. The carrying amounts of raw materials, stores and spare parts are appropriately written down when there is a decline in replacement cost of such materials and the finished products, in which they will be incorporated, are expected to be sold below cost.

Work in progress and finished goods are valued at the lower of cost and net realisable value. Cost comprises of direct material, labour expenses and an appropriate portion of production overheads incurred in bringing the inventory to their present location and condition. Fixed production overheads are allocated on the basis of normal capacity of the production facilities.

Traded finished goods are valued at the lower of cost and net realisable value.

x. Revenue

Revenue from sale of goods is recognised when significant control of ownership in the goods are transferred to

customers and it is not unreasonable to expect ultimate collection of the sale consideration that is being recognised as revenue.

Dividend income is recognised when the right to receive payment is established.

Interest income is recognised on a time proportion basis taking into account the amount outstanding and the interest rate applicable.

xi. Income from Government Grant

The Company may receive government grants that require compliance with certain conditions related to the Company's operating activities or are provided to the Company by way of financial assistance on the basis of certain qualifying criteria.

Government grants are recognised when there is reasonable assurance that the grant will be received, and the Company will comply with the conditions attached to the grant.

Accordingly, government grants:

- a. related to or used for assets are included in the Balance Sheet as deferred income and recognised as income over the useful life of the assets.
- b. related to incurring specific expenditures are taken to the Statement of Profit and Loss on the same basis and in the same periods as the expenditures incurred.
- c. by way of financial assistance on the basis of certain qualifying criteria are recognised as they become receivable. In the unlikely event that a grant previously recognised is ultimately not received, it is treated as a change in estimate and the amount cumulatively recognised is expensed in the Statement of Profit and Loss.

xii. Foreign exchange transactions

Transactions in foreign currencies are translated into the functional currency at the exchange rates prevailing on the date of the transactions. Foreign currency monetary assets and liabilities at the year-end are translated at the year-end exchange rates.

Non-monetary items which are carried in terms of historical cost denominated in a foreign currency, are reported using the exchange rate at the date of transaction. The loss or gain thereon and also on the exchange differences on settlement of the foreign currency transactions during the year are recognized as income or expense in the statement of profit and loss.

Foreign exchange gain/loss to the extent considered as an adjustment to Interest Cost are considered as part of borrowing cost.

xiii. Employee benefits

The Company's obligations towards various employee benefits have been recognised as follows:

Short term benefits

Employee benefits payable wholly within twelve months of receiving employee services are classified as short-term employee benefits. These benefits include salaries and wages, bonus and ex-gratia. The undiscounted amount of short-term employee benefits to be paid in exchange for employee services is recognised as an expense as the related service is rendered by employees.

Post-employment benefits

- a) Monthly contributions to Provident Funds which are in the nature of defined benefit schemes are charged to Statement of Profit and Loss and deposited with the Provident Fund administered through the Company's trust on a monthly basis.
- b) The administration of the gratuity scheme which is in the nature of defined benefit plan, has been entrusted to Life Insurance Corporation of India ('LIC'). Annual charge is recognised on the basis of actuarial valuation at the Balance Sheet date, conducted by an independent actuary appointed by the Company and payments are made to LIC on the basis of annual demand received from them. The Company recognizes all actuarial gains and losses in the Statement of Profit and Loss.

Other long term benefits

Cost of long term benefit by way of accumulating compensated absences are recognised when the employees render the service that increases their entitlement to future compensated absences. Such costs are recognised based on actuarial valuation of the Company's year end obligation in this regard by an independent actuary.

Termination benefits

Costs of termination benefits have been recognised only when the Company has a present obligation as a result of a past event, it is probable that an outflow of resources will be required to settle such obligation and the amount of the obligation can be reliably estimated.

xiv. Income taxes

Income-tax expense comprises current tax (i.e. amount of tax for the period determined in accordance with the income-tax law) and deferred tax charge or credit (reflecting the tax effects of timing differences between accounting income and taxable income for the period).

- a. Current tax is measured at the amount expected to be paid to (recovered from) the taxation authorities, using the applicable tax rates and tax laws.
- b. Deferred tax is recognized on temporary differences between the carrying amounts of assets and liabilities and the amounts used for taxation purposes (tax base), at the tax rates and tax laws enacted or substantively enacted by the end of the reporting period.

Deferred tax assets are recognised for the future tax consequences to the extent it is probable that future virtual certainty will be available against which the deductible temporary differences can be utilised.

Income tax, in so far as it relates to items disclosed under other comprehensive income or equity, are disclosed separately under other comprehensive income or equity, as applicable.

Deferred tax assets and liabilities are offset when there is legally enforceable right to offset current tax assets and liabilities and when the deferred tax balances related to the same taxation authority. Current tax assets and tax liabilities are offset where the entity has a legally enforceable right to offset and intends either to settle on net basis, or to realize the asset and settle the liability simultaneously.

Deferred tax assets are reviewed as at each balance sheet date and written down or written-up to reflect the amount that is reasonably certain (as the case may be) to be realised.

xv. Dividend Distribution

Dividends paid is recognised in the period in which the interim dividends are approved by the Board of Directors, or in respect of the final dividend when approved by shareholders.

xvi. Provisions and Contingent liabilities

Provisions are recognized only when there is a present obligation, as a result of past events, and when a reliable estimate of the amount of obligation can be made at the reporting date. These estimates are reviewed at each reporting date and adjusted to reflect the current best estimates.

Contingent liability is disclosed for:

- Possible obligations which will be confirmed only by future events not wholly within the control of the Company or
- Present obligations arising from past events where it is not probable that an outflow of resources will be required to settle the obligation or a reliable estimate of the amount of the obligation cannot be made.

xvii. Operating leases

Lease payments on operating lease agreements are recognised as an expense on a straight-line basis over the lease term unless the payments are structured to increase in line with expected general inflation to compensate for the lessor's expected inflationary cost increases. Associated costs, such as maintenance and insurance, are expensed as incurred.

xviii. Operating Segments

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker (CODM). The CODM who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the Board of Directors of the Company.

xix. Earnings per share

Basic earnings per share is calculated by dividing the net profit or loss for the period attributable to equity shareholders (after deducting attributable taxes) by the weighted average number of equity shares outstanding during the period. The weighted average number of equity shares outstanding during the period is adjusted for events including a bonus issue.

For the purpose of calculating diluted earnings per share, the net profit or loss for the period attributable to equity shareholders and the weighted average number of shares outstanding during the period are adjusted for the effects of all dilutive potential equity shares.

2. FINANCIAL RISK MANAGEMENT

The Company's business activities are exposed to a variety of risks including liquidity risk, credit risk and market risk. The Company seeks to minimize potential adverse effects of these risks by managing them through a structured process of identification, assessment and prioritization of risks followed by coordinated efforts to monitor, minimize and mitigate the impact of such risks on its financial performance and capital. For this purpose, the Company has laid comprehensive risk assessment and minimization/mitigation procedures, which are reviewed by the Audit Committee and approved by the Board from time to time. These procedures are reviewed to ensure that executive management controls risks by way of properly defined framework. The Company does not enter into derivative financial instruments for speculative purposes. The following table explains the sources of risk and how the entity manages the risk in its financial statements. The management reviews the status of all principal risks with a significant potential impact. Additionally, the Audit Committee carried out focused risk reviews of each Plant and divisions. These reviews included an analysis of both the principal risks, and the controls, monitoring and assurance processes established to mitigate those risks to acceptable levels. As a result of these reviews, a number of actions were identified to continue to improve internal controls and the management of risk.

a. Credit Risk

Credit risk arises from the possibility that the counter party may not be able to settle their obligations as agreed. Credit risk arises from cash and cash equivalents, investment carried at amortised cost, deposit with banks and financing institutions as well as credit exposure to customer and other parties.

For banks and financial institutions, only high rated banks/institutions are accepted. For other financial assets, the entity assesses and manages credit risk based on internal credit evaluation. It monitors party-wise exposure and based on evaluation credit rating is allotted for each party. Thereafter a credit limit is assigned to each party depending on the solvency of the said party.

The entity considers the probability of default on ongoing basis and at each reporting period. Micro-economic information is incorporated as part of internal rating model.

b. Liquidity Risk

The company objective is to at all times maintain optimum level of liquidity to meet its cash and collateral requirement at all times. The Company relies on Borrowing to meet its additional need for fund. The current committed lines of credit are sufficient to meet its short to medium term expansion needs and hence evaluates the concentration of risk with respect to liquidity as low. The Company monitors rolling forecasts of its liquidity requirements to ensure it has sufficient cash to meet operational needs while maintaining headroom on its undrawn committed borrowing facilities at all times so that Company does not breach borrowing limits or covenants (where applicable) on any of its borrowing facilities.

The company is required to maintain debt equity ratio as mentioned in the loan agreements at specified levels. In the event to meet any ratios these become callable at the option of the lenders, except where exception is provided by lender.

c. Market Risk

Market risk is the risk that the fair value of future cash flow of financial instruments may fluctuate because of changes in market conditions. Market risk broadly comprises three types of risks namely currency risk, interest rate risk and price risk (for commodities or equity instruments).

- (i) Foreign Exchange Risk – The company operates only in India and has not entered in to any foreign exchange or commodity derivative contracts. Accordingly there in no significant exposure to market risk.
- (ii) Interest Rate Risk – Interest rate exposure of the Company is mainly on Borrowing from Bank/FI, which is linked to their prime lending rate and the Company does not foresee any risk on the same.
- (iii) Security Price Risk – The Management invests its surplus funds in mutual funds operated by only high rated banks/institutions. These investments are generally short-term and accordingly there in no significant exposure.

I. Post Employment Defined Benefit Plans :

(A) Gratuity (Funded)

The Company provides for gratuity, a defined benefit retirement plan covering eligible employees. As per the plan, the Gratuity Fund Trusts, administered and managed by the Trustees and funded primarily with Life Insurance Corporation of India (LIC), make payment to vested employees at retirement, death, incapacitation or termination of employment, of an amount based on the respective employee's salary and the tenure of employment. Vesting occurs upon completion of one years of service. The Trustees are responsible for the overall governance of the plan and to act in accordance with the provisions of the trust deed and rules in the best interests of the plan participants. Each year an Asset-Liability matching study is performed in which the consequences of the strategic investment policies are analysed in terms of risk and return profiles. Investment and contribution policies are integrated within this study. Liabilities with regard to the Gratuity Plan are determined by actuarial valuation as set out in Note 1B(ii) (4) based upon which, the Company makes contributions to the Employees' Gratuity Funds.

(B) Provident fund

Contributions towards provident funds are recognised as expense for the year. The Company has set up Provident Fund Trusts in respect of certain categories of employees which are administered by Trustees. Both the employees and the Company make monthly contributions to the Funds at specified percentage of the employee's salary and aggregate contributions along with interest thereon are paid to the employees/nominees at retirement, death or cessation of employment. The Trusts invest funds following a pattern of investments prescribed by the Government. The interest rate payable to the members of the Trusts is not lower than the rate of interest declared annually by the Government under The Employees' Provident Funds and Miscellaneous Provisions Act, 1952 and shortfall, if any, on account of interest is to be made good by the Company.

In view of the Company's obligation to meet shortfall, if any, on account of interest, Provident Fund trusts set up by the Company are treated as defined benefit plans.

During the year, the Company's contribution of Rs. 5,979 (Previous year – Rs. 6,002) to the Provident Fund Trusts has been expensed under the 'Contribution to Provident and Other Funds' in Note 24.

II. Post Employment Defined Contribution Plans

Superannuation Fund

Certain categories of employees of the Company participate in superannuation, a defined contribution plan administered by the Trustees. The Company makes quarterly contributions based on a specified percentage of each covered employee's salary. The Company has no further obligations under the plan beyond its annual contributions.

III. Leave Obligations

The Company provides for accumulation of leave by certain categories of its employees. These employees can carry forward a portion of the unutilised leave balances and utilise it in future periods or receive cash (only in case of earned leave) in lieu thereof as per the Company's policy. The Company records a provision for leave obligations in the period in which the employee renders the services that increases this entitlement.

The total provision recorded by the Company towards this obligation was Rs.13,599 (as at 31 March, 2025 Rs. 10,297). The amount of the provision is current, since the Company does not have an unconditional right to defer settlement for any of these obligations. However, based on past experience, the Company does not expect all employees to take the full amount of accrued leave or require payment within the next 12 months. Rs. 10,089 (as at 31 March, 2025 Rs. 7,517) is not expected to be taken or paid within the next 12 months and shown under Non-current portion.

IV. Risk Exposure

Through its defined benefit plans, the Company is exposed to some risks, the most significant of which are detailed below:

Discount Rate Risk

The Company is exposed to the risk of fall in discount rate. A fall in discount rate will eventually increase the ultimate cost of providing the above benefit thereby increasing the value of the liability.

Salary Growth Risks

The present value of the defined benefit plan liability is calculated by reference to the future salaries of plan participants. An increase in the salary of the plan participants will increase the plan liability.

Demographic Risk

In the valuation of the liability, certain demographic (mortality and attrition rates) assumptions are made. The Company is exposed to this risk to the extent of actual experience eventually being worse compared to the assumptions thereby causing an increase in the benefit cost.

Hon'ble Supreme Court vide its Judgement dated 06th December, 2019 in another case held that when a particular kind of duty is exempted, other types of duty or cess imposed by different legislation for a different purpose cannot be said to have been exempted and therefore, has over ruled its earlier Judgement dated 10th November, 2017. Pursuant to this judgement the Company during the financial year 2019-20 recognized liability of Rs. 24,14,295/- on account of Education Cess and Higher Education Cess, which was earlier refunded during the financial year 2018-19 and 2019-20 by reversal of Income and charging it off as expense in the financial year 2019-20.

On 28th July, 2020 and 21st September, 2020 the Assistant Commissioner, Central Goods & Service Tax, Guwahati Division II, issued Demand cum Show Cause Notices asking the Company to show cause as to why the Education Cess and Secondary and Higher Education Cess refunded to the Company shall not be demanded back along with interest.

On 10th September, 2020 and 12th October, 2020 the Company filed two Writ Petitions before the Hon'ble Guwahati High Court challenging the said Demand cum Show Cause Notices, which was allowed by the Court on 22nd September, 2020 and 21st October, 2020 by setting aside the aforesaid Demand cum Show Cause Notice.

Being aggrieved by the judgments of Hon'ble Guwahati High Court, the Department filed Appeals before the Division Bench of the High Court challenging the aforesaid judgments, which the Division Bench has dismissed on 08th October, 2021.

In the situation, the matter is still considered sub-judice and other costs associated with this, being indeterminate, will be considered in these accounts on finality.
